

# **SOUTH FERRIBY LIAISON GROUP**

## **MEETING MINUTES FOR 28th APRIL 2017**

**Matters Arising:** There were no matters arising following the last meeting. The minutes of the last meeting were accepted.

**CEMEX:** JP reported that since the last meeting there had been no accidents or lost time injuries. Kiln 2 had undergone a month long outage for repairs during March 2017 with over 100 extra contract personnel on-site. During the repairs only two minor first aid treatments occurred. To celebrate a buffet was laid on at the Hope and Anchor pub for all the people on-site.

Since the last meeting the plant received one complaint regarding the site being generally noisy and it had reported itself twice for emission breaches. Once was for high carbon monoxide readings caused by poor quality raw meal and the other was failure of the precipitator associated with kiln 3 resulting in high dust emissions so the kiln was stopped and repairs conducted.

JP went on to mention that the plant was looking at different coals as a means of achieving its future oxides of nitrogen (NOx) and sulphur dioxide (SO2) emission limits. KV asked if everyone was achieving their NOx limits. HG replied that the regulations that the cement plant operate under affects everyone in Europe.

JP then tabled clinker, cement and alternative fuels usage data for the plant. SH asked why is the plant not at the Climafuel levels it was before the flood?. JP replied that the plant was trying to increase its use and March with only one kiln operation, was a good time to maximize its usage. Unfortunately the material sent had a high water content exacerbated by the material sweating in the trailers when stood on-site. The chimney design also limits performance and the SLF plant was shut down for one week for its annual maintenance outage.

Kiln 2's maintenance outage over-ran from a planned 25 days to 35 days due to a crack being found in the kiln shell that required extra brickwork to be removed, the crack welded and then the brickwork replaced. Humberside Fire and Rescue provided 24/7 safety coverage for the plant during this outage and will be used again.

SH reported upon her investigations into the temporary closure of the A1077 through the village utilising 'Clugston personnel' on the weekend in January of the expected high tides. A mysterious Mr X gave permission for a Clugstons' tanker to pass through the barrier and through the village to the Cement Plant. SH reported that she felt better communications were needed between The Environment Agency and CEMEX and also CEMEX to their own (or sub contracted) tanker drivers. There were also many issues and improvements needed by North Lincolnshire Council generally.

**Environment Agency:** Nothing to add to that what had already been discussed.

**North Lincolnshire Councilors:** Nothing to add

**North Lincolnshire Council Officers:** Since the last meeting all air quality objectives compliant.

The wind direction for most of 2017 has come from the South and West. Pm 10 calendar plot showed two events (3 days) that exceeded an average result of 50 daily average. One event was a local event but the other was a regional event.

RV announced that he was leaving the council and wished the group well. As yet there is no replacement.

**Winteringham Parish Council:** Tour of Britain cycling event coming down A1077 in September and through local villages. Good publicity for area.

**South Ferriby Parish Council:** SH asked when is the next edition of Community Matters being issued. JP replied that one is being drafted for issue mid year.
