1112/4 Public Comment

a. Sluice Road Bus Shelter (information forwarded 22/11/11)

The Council discussed the matter with Ward Cllr Nigel Sherwood and various options were considered. It was agreed for Ward Cllr Sherwood to continue discussions with NLC Highways to try and make progress and it was asked that the item be re-agenda'd for the February meeting.
