##### **20/21 –FPC0303 Minutes of Previous meeting**

- a) Resolved – That the minutes of the Flood Protection Committee meeting held on Monday 25<sup>th</sup> January 2021 were reviewed and agreed as an accurate and true record and signed accordingly.

##### **20/21 –FPC0304 Flood Defence Works**

- a) Councillors discussed the following points:
  - i) Councillor Haddon gave an update stating that the CEMEX Gate was complete and that piling around the Hope and Anchor had been completed ahead of schedule
  - ii) Councillors discussed outstanding drainage issues, stating that there were 3 main areas, The East Bank drainage is now complete. CEMEX Football field drainage is a complex issue, however there are plans to rectify it, but we will not know if it works until we have a prolonged period of wet weather. There is also drainage to be completed around CEMEX Bund
  - iii) Councillors discussed that there were no residual issues from the road closure.
  - iv) Councillors discussed reinstatement works from a Village perspective, Cllr Haddon confirmed that Bentley's are not yet in a position to have a walkaround inspection, Cllr Holloway confirmed he would attend the inspection.
  - v) Councillors discussed the response to piling, one resident had raised concerns with the EA, which had been addressed. It was noted that communication from the EA had been poor as some houses had been missed, but that although very loud, vibration from the piling had been minimal.
  - vi) Councillors discussed road traffic signs and speed restrictions, NLC have taken charge of this. There had been a proposal to extend the 30mph limit to CEMEX Gate 1, however this had not been carried forward..
  - vii) Councillors discussed remaining works for 2021, stating that the Village would be watertight by the end of April, as there were some further works to the demountable section of Sluice scheduled for w/c 23<sup>rd</sup> April. Reinstatement works will continue through to June.
