### Public Participation

A member of the public spoke to ask why works had not been completed in the play area, as this was a minuted action from the June meeting.

Cllr Holloway stated that unforeseen circumstances in respect of both the Chair and Clerk had prevented this from being completed before the July meeting.

The member of the public also cited that works completed in the play area by volunteers from the Village had uncovered a very thorny shrub that required removal.

A member of the public spoke to ask who owned the dyke that runs alongside the pavement on the A1077 Sluice Road as it requires clearing.

Cllr Waltham responded that ownership would be according to Riparian rights

The member of the public also cited that the pavement was very narrow, and they had witnessed a resident who uses a wheeled walker having their wheels on the grass on one side, the pavement also requires resurfacing.

The member of the public also raised that the pavement on the opposite side of the A1077 is giving way.

## **22/23 – 0704      Report from Ward Councillors**

Cllr Rob Waltham gave an update stating that North Lincs had received £5.5mil in UK prosperity funding from the Government, and that NLC would be looking to distribute this in the form of many smaller grants to communities.

Nominations for Community Champions opened on 16th June, and will close on 30th September.

A new web service has been launched – Live Well North Lincs – that is a hub for help with improving health and fitness and information on activities and events across North Lincolnshire.

Free swimming sessions for under 16's will be available at all NLC leisure centres from 25th July to 4th September.

## **22/22 – 0705      Highways & Footpaths**

a) Councillors discussed progress since the Village Highways Site Visit on the following issues:

- Missing 30mph sign at CEMEX Gate – Resolved
- Footpath alongside A1077 Sluice Road and drainage from A1077 – Clerk to send photographs to Cllr Waltham
- Footpath at top of School Lane – No update
- Abandoned cars in the car park – No update
- Dropped Kerb and footpath widening at the Viking on the High Street – No update
- Potholes on Horkstow Road – This has been marked as a Ward priority and will be completed in the 2022/23 financial year
- Road breaking up North End – This is not on the list for resurfacing, however patching may be undertaken
- The white line at the junction of Cliff Road and North End has faded and is no longer visible – No update

b) Councillors also raised the following Highways issues:

- Weeds are growing in the kerbside on the A1077 hill. Councillors queried why these works were not completed during the recent road closure for gulley cleaning.

  - ii) A budget of £200 was requested for planting over the forthcoming month.

Resolved - Cllr Fisher proposed a £500 budget for Open Space spending, this was seconded by Cllr Holloway.

- d) Councillors discussed the quote for paint and painting the container near the MUGA

Resolved – That the quote be accepted.

- e) Councillors discussed the SLA agreement for emptying the bins in the Play Area , and Cliff Road

Resolved – To accept the SLA agreement

- f) Cllr Holloway stated that the Bowls Club have requested a draft formal agreement from the Parish Council.
