Public Participation

Cllr Haddon updated that she had been researching fibre broadband offerings within the Village. The previous Quickline microwave system is no longer operational, however Quickline and internetty have offerings for direct to property fibre utilising overhead wires from telegraph poles, with the timelines for installation from both companies being similar. KCom have not provided an update, but are looking at providing fibre in South Ferriby.

22/23 – 0204 Report from Ward Councillors

a) Cllr Rob Waltham gave an update stating that NLC had set the budget with no increases to general Council Tax, there was a 1.75% increase on Adult Social Care, which was below the Government recommended increase of 2%. Free car parking, Imagination Library and Free Swimming had been preserved through this budget.
